CONDITIONS:					

1. Intradistrict transfers are only valid while the conditions stated in the request are maintained.
2. Intradistrict transfers may be revoked if the student does not maintain satisfactory attendance, citizenship, or scholarship.
3. Transportation of the student to and from school is the responsibility of the parent or guardian.
4. The student will be ineligible for varsity athletics for one calendar year from the date of enrollment at the high school of desired attendance.

Ineligibility Exemption

Incoming ninth grade students, ninth grade siblings of students concurrently enrolled at the high school, students of any grade level whose parents relocate during the year, and ninth grade students granted a transfer to an "optional enrollment school" declared by the District; tenth, eleventh, and twelfth grade students granted a transfer to an "optional enrollment school" declared by the District.

5. If a student is granted a request to voluntarily return to his/her school of residence, the student will be ineligible at the school of residence for varsity athletics for one calendar year from the date of re-entering his/her school of residence.
6. If an Intradistrict Transfer is approved, the student may remain at the school until completion, but must re-apply for an Intradistrict Transfer for the next level.
7. **Approved requests remain in effect for a minimum of one school year unless revoked by the school or the District Office.**
